- 3. Has been actively involved in the affairs of SBIA (e.g., worked as an officer, volunteer, committee member, assisted or worked or taught at Islamic School), and
- 4. Contributed an accumulated sum of \$5,000 or more to SBIA.

#### **Requirements for Voting Members are as follows (also required of Trustee nominees):** Any Muslim who:

- 1. Is at least 16 years of age,
- 2. Has filled out the current membership form and signed the Arbitration Agreement
- 3. Has paid the annual membership due,
- 4. Is a resident of the San Francisco Bay Area,
- 5. Believes in the Unity of Allah,
- 6. Asserts that Prophet Muhammad (SAWS) is the Last and Final Prophet of Allah (SWT), and,
- 7. Is sympathetic to the causes of this Association, and has indicated an interest in furthering its aims, may become a voting member of this Association.

In addition, in order to be considered as a nominee, the nomination has to be seconded by another member of SBIA and approved by the nominee himself or herself.
