2. Has filled out the current membership form and signed the Arbitration Agreement
3. Has paid the annual membership due,
4. Is a resident of the San Francisco Bay Area,
5. Believes in the Unity of Allah,
6. Asserts that Prophet Muhammad (SAWS) is the Last and Final Prophet of Allah (SWT), and,
7. Is sympathetic to the causes of this Association, and has indicated an interest in furthering its aims.

Please note that, as stated in the nomination form below, in order to be considered as a nominee, the nomination has to be seconded by another voting member of SBIA and approved by the nominee himself or herself.
