1. Be a Muslim [Must believe in the unity of Allah (SWT), and the finality of Prophet Muhammad (S).]
2. Must be 19 years of age or older by January 1, 2019
3. Must be a US Citizen or Permanent Resident of Santa Clara, Santa Cruz, San Mateo, or Alameda Counties, CA, USA.
4. Has been an eligible voting member of SBIA for past 3 years and donated \$850 per year between July 1st 2015 to June 30th 2017 and \$900 between July 1st 2017 & June 30th 2018 to Operating Funds or New Masjid.
