Voter Eligibility

- 16 years or older Muslim
- Resident of Santa Clara, Santa Cruz, San Mateo or Alameda County
- Has Paid SBIA Membership of \$250 per person (\$50 for student and Senior Citizen 60 years & older) between July 1st 2018 and June 30th 2019 towards Operating Funds or New Masjid
- Signed the Arbitration Agreement with SBIA

Board of Director Eligibility

19 years or older; US citizen or permanent resident

Is an eligible Voting Member for last 3 Years and has donated \$850 per year between July 1st 2016 to June 30th 2017 and \$850 per year between July 1st 2017 to June 30th 2018 and \$850 between July 1st 2018 & June 30th 2019 to Operating Funds or New Masjid .

Should make Board recommended donations every year when serving as Director

Has Not Served 3 Consecutive Terms as a Director unless previous 2 to fill vacancy of 18 months or less

Does Not have an immediate family member on the Board of Director / Trustees

Board of Trustee Eligibility

25 years or older, US citizen or permanent resident

Is an eligible Voting Member for last 5 Years and has donated \$850 per year between July 1st 2016 to June 30th 2017 and \$850 per year between July 1st 2017 to June 30th 2018 and \$850 between July 1st 2018 & June 30th 2019 to Operating Funds or New Masjid .

Should make Board recommended donations every year when serving as Trustee

Has Not completed 2 terms as Trustee

Is Not a member of the Current Board of Directors

Does Not have an immediate family member on the Board of Director / Trustees
