A candidate must be nominated and seconded by current SBIA members using this form. Each community member can nominate one individual.

Nominees for the Board of Trustees must fulfill the following conditions:

- .. Be a Muslim [Must believe in the unity of Allah (SWT), and the finality of Prophet Muhammad (S).]
- .. Must be 22 years of age or older by January 1, 2023
- .. Must be a US Citizen or Permanent Resident in Santa Clara, Santa Cruz, San Mateo, or Alameda Counties, CA, USA.
- .. Must either have served at least one complete term as a Director of the association OR have been a financial contributor to SBIA in the accumulated sum of \$5000 in last 5 years.
- .. Has been an eligible voting member of SBIA for past consecutive 3 years and has donated \$1000 per year between July 1st 2019 - June 30th 2020, and \$1000 from July 1st 2020 - June 30th 2021 and \$500 from July 1st 2021 - June 30th 2022 to Operating Funds, Loan Payoff or Construction expenses.
